NOTIFICATION

Based on the deliberations, the following decisions were taken

Item 1: Affiliated Colleges – Industrial Training / Internship (R 2017) – Number of weeks of course against Number of credits to be made uniform.

The duration for Industrial Training / Internship is not mentioned in Regulations R-2017. The period of Internship for earning 1, 2 or 3 credits courses are not uniformly reflected in the Curriculum.

Therefore, the committee decided that the following necessary amendment is to be made in **Clause 4.5 of Regulations 2017** for Affiliated Colleges.

DURATION OF INDUSTRIAL TRAINING / INTERSHIP	CREDITS
2 Weeks	1
4 Weeks	2
6 Weeks	3

The above mentioned changes shall be implemented prospectively.

This is to be ratified in the forthcoming Academic Council.

Item 2: Assessment Methods for Mini Projects / Mini Project and Seminar.

The Mini Project/ Mini Project and Seminar shall carry 100 marks and shall be evaluated through three reviews as continuous assessments. The first and second reviews are to be evaluated by a three member internal committee constituted by the Principal of the College, which includes the guide. At the end of the semester the student shall submit a brief report on the Mini Project. **The third review will be conducted based on this report and Viva-Voce Examination conducted by the committee constituted by COE.**

The amendment shall be incorporated in the Regulations 2017 for Affiliated Institutions and the breakup of marks is given in the Table below:
