With reference to the cited above, I am to inform that remuneration fixed to Practical and Theory Examinations for the conduct of November/December 2020 (Re examination)and April/ May 2021 as follows :

THEORY EXAMINATIONS :

The Remuneration for the Chief Superintendent as per the University norms is Rs. 250/- per session.

Faculty member engaged in the examination activity is eligible for Rs. 6/- per script for processing a candidate present for the examination subject to a minimum of Rs. 50/- per course.

The Stationery expenditure is fixed at Rs.4/- per candidate who has registered and present for atleast one examination subject to a minimum of Rs.500/-.

PRACTICAL EXAMINATIONS :

The remuneration for the Internal and External Examiners is Rs.10/- for each candidate examined per practical subject with a minimum of Rs. 75/- .

VIVA-VOCE EXAMINATIONS :

1. The remuneration for the Viva-Voce Examinations for UG Project work as per the university norms is Rs. 40/- per group subject to a minimum of Rs. 100 /- (No.of examiners 2)
2. The remuneration for the Viva-Voce Examinations for B.Arch Project work as per the university norms is Rs.40/- per candidate subject to a minimum of Rs. 100 /- (No.of examiners 3)
3. The Viva-voce examinations of PG Project work, the remuneration for the internal, external examiners and the supervisor as per the University norms Rs. 50 /- per candidate subject to a minimum of Rs. 100/- (No.of examiners 3) and the evaluation of PG thesis Rs. 100/- per candidate.
4. The Viva-voce examinations of Studio based courses of B.Arch/M.Arch , programmes, as per the university norms the remuneration is Rs. 50/- for each candidate registered per subject with a minimum of Rs. 100 /- (for 3 examiners)
