It is hereby informed that the Goods and Services Tax Act, 2017 [GST] has been adopted by the University and GST Registration Number for the office of the Controller of Examinations has been assigned as 33-AAALR-0284-R1ZK.

The services which are part of curriculum are exempted under GST. All other services which are not part of the curriculum to be taxable as per the GST Act 2017.
