It is informed that the Practical Examinations and Viva-Voce examinations for Studio based Courses of the November-December 2021 Examinations were previously scheduled between 03-01-2022 and 12-01-2022 following the instructions of the Registrar of the University, vide Ref.1. As per the schedule, the

examinations were successfully conducted from 03-01-2022 to 05-01-2022.

Due to increasing trend of COVID-19, the Government of Tamil Nadu issued a G.O., vide Ref.2, stating that "Holiday is declared upto 20.01.2022 to all colleges and polytechnic institutions except both Government, Private, Medical and allied medical, institutions for enabling the students to prepare for their examinations". Accordingly, the practical examinations scheduled from 06-01-2022 were cancelled.

Further, the theory examinations of the under-graduate programmes and five year integrated programmes were scheduled in online mode as directed by the Government, vide Ref.3, from 01-02-2022 onwards and the same comes to end on 06-03-2022 for Regulations 2013, 2015 and 2017 and 11-03-2022 for other Regulations. Therefore, it is proposed to conduct the pending practical examinations and Viva-Voce examinations for Studio based Courses and the same are scheduled in physical mode as given below.
