The IIC cell and IPR cell of JIT has jointly organized an awareness program on “KAPILA scheme-Kalam Program for IP Literacy and Awareness and a panel discussion on Patent Protection. The programme was conducted on 4-2-2022 at 11.00 am in seminar hall. The faculty members of JIT attended the awareness session and the various teams presented their patents followed by the discussion.

The IPR cell coordinator welcomed the participants and delivered the welcome address. The importance of innovation, idea generation and its protection was emphasized in the welcome address. Following the welcome address, the IIC cell coordinator, Dr.M.Matheswaran introduced the “KAPILA Scheme” to the participants. He explained about the financial assistance provided the Government of India, to the higher education Institutions for filing patents. He described the objective of the Kapila scheme as to is to recognize, facilitate and felicitate the Intellectual Property, innovations, and best practices in HEIs and filing about 10,000 patents per year. He explained about the guidelines of the scheme and the terms and conditions to be noted. The expert committee formed at the institution level was presented to the participants. He also projected about the status of number of publications in the country and how many publications are converted to product.

Followed by the awareness on Kapila scheme, the team members presented their invention with prior art. Totally 10 teams made up their presentation followed by the discussion by the panelist. The mode of protection for each invention was discussed and the details required for patenting was explained. The session ended with vote of thanks by the IPR cell coordinator.

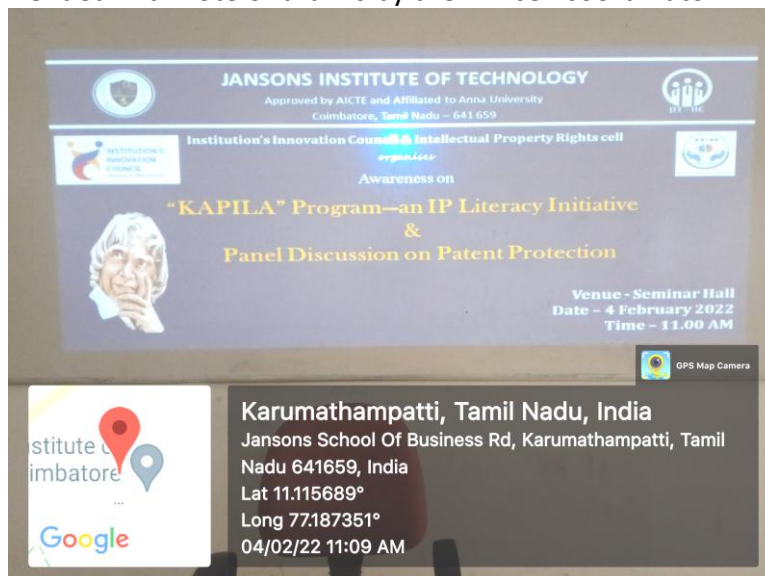


Figure 1 The event details of the Awareness on "KAPILA scheme-an IP Initiative and panel discussion on Patent

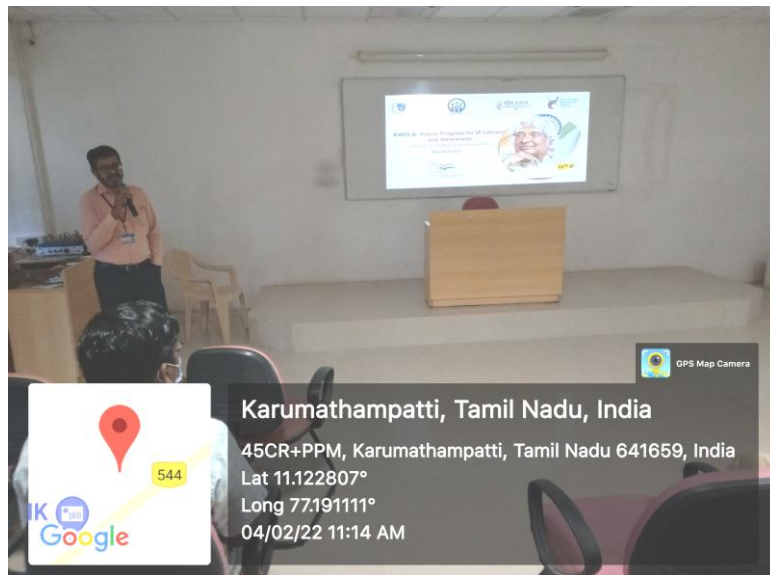


Figure 3 Dr.M.Matheswaran, IIC cell coordinator explaining the Kapila scheme to the audience
